MOTION TO ALTER BRIEFING SCHEDULE

Relator Ervin and Associates, Incorporated, et al. ("Ervin"), by counsel, hereby moves this Court to alter the Briefing Schedule as described in this Court's Order of April 18, 2000, on the following grounds:

- 1. The current Scheduling Order allows Relator Ervin and Associates, Incorporated ("Ervin") and the Government to file supplemental oppositions to Defendant Hamilton Securities Group, Inc., et al.'s ("Hamilton") Motion to Unseal File on or before April 28, 2000.
- 2. Ervin also respectfully requests that the hearing on Hamilton's Motion to Unseal File be continued until May 22, 2000, or such time thereafter as is convenient to the Court.
