On March 4, 1997, I appealed Ms. Aldrich's February 20th final response to the above-referenced FOIA request based on HUD's over broad application of Exemption 4 in refusing to disclose losing bidder information. I have yet to receive a response to that appeal.

Although I was originally under the impression that complete information had been provided for winning bids, I have since done considerable work attempting to summarize HUD's note sales and have discovered that there was a significant amount of information that was withheld from us without explanation.

Although our initial request, dated October 2, 1996, asked for information on all single family and multifamily note sales to date, for some reason the response excluded the following sales in their entirety:

Multifamily Sale to Fannie Mae
Single Family G-4 Note Sale
Multifarnily G-4 Note Sales
Single Family Defaulted Title I Notes
Single Family Defaulted Title I Notes #2
Multifamily Sale to Missouri HFA

in addition, for note sales that were addressed in the response, the following information was not provided:

- Amounts of Winning Bids
- Addresses of Bidders

Pools Included in Each Winning Bid

Single Family Sale #3

- Pools Included in Each Winning Bid
- Names and Addresses of Losing Bidders

As none of the above information was claimed as exempt, I believe this was an error on HUD's part and Ms. Aldrich should provide the required information without an appeal. However, if this is not the case, please consider this a formal appeal of the withholding of the above information, in addition to our previous appeal (which is still pending) of the withholding of losing information.

In addition, on February 27, 1996, we requested identical information on the 12/14/96 Midwest Sale and the 1/30/97 Single Family Sale #4. For some as of yet unexplained reason, HUD has released minimal information regarding these sales although each has already closed. Please ensure that HUD's decision to be less than forthcoming with the press about note sales is not to be confused with their obligations under the FOIA. All information that has been (or should have been) provided for the previous note sales under the Freedom of Information Act should also be released for these two

sales, including the losing bid information if our appeal is upheld (either by HUD's Office of the General Counsel or the District Court).

I have also recently submitted a FOIA request to HUD regarding a Title X land sale which was held sometime in 1996. Please ensure complete, prompt disclosure regarding that sale as well.
